**Delta, Colorado, April 13, 2020 – Delta County Daily Update**

 **UPDATED Testing Information:**

The Colorado Department of Public Health and Environment is reporting 7 positive cases in Delta County. Delta County Health Department is investigating the seventh case; the individual is a female in her 30's who is self-isolating.

To date, 168 tests have been administered at Delta County Memorial Hospital. The results are 162 negative, 2 positive, and 4 pending.

Delta County Health Department is reporting 1 death of a Delta County resident in their 70's, who had underlying medical conditions, and had been a resident at an assisted living facility outside of Delta County.

Delta County Memorial Hospital continues to follow the same criteria that is followed regionally in that they are testing high-risk, hospitalized inpatients, essential and symptomatic healthcare workers, and individuals on a case-by-case basis.

**What to do if you're sick:**

- Self-Isolate. If you develop a fever, cough or shortness of breath you may need to call your healthcare provider. Do not show up at a clinic, urgent care or the emergency department without calling ahead.
- Wear a mask and cover your cough or sneeze.
- Wash your hands frequently and don't share personal items (drinking glass or utensils) with others.
- If possible, sleep in a bedroom and use a bathroom that is not used by other household members.
- Getting rest and drinking plenty of fluids will likely be helpful for recovery.

Public Health officials also recommend residents prepare for an emergency that might require them to stay at home for several days, including having food supplies, water and medications.

**Protect yourself:**

- Wear a mask when you leave your home or yard.
- Practice social distancing
  - Try to keep 6 feet between yourself and other people whenever possible, particularly when you or others are sick. No hugs, no handshakes.
  - Wash your hands regularly, especially before eating or touching your mouth and nose.
- Avoid close contact with people who are sick.
- Cover your cough or sneeze with a tissue, then throw the tissue in the trash.
- Clean and disinfect frequently touched objects and surfaces using a regular household cleaning spray or wipe.

#### **Social Distancing**

The Emergency Operations Center is aware of reports of informal gatherings and poor trail etiquette. Social distancing or a physical distance of AT LEAST six feet in between yourself and those outside your immediate family is important to stopping the spread of this virus, and ultimately flattening the curve.

Please limit grocery shopping trips to one family member, and only try to shop once per week or as infrequently as possible. We encourage the public to have food and supplies (as possible) for two weeks. Please do not hoard supplies; this is a community effort and hoarding only harms overall community response and preparedness efforts. Please be kind and respectful to your neighbors.

#### **Delta County Emergency Services**
